Clerk Dawn Czech read the April, 2025 meeting minutes. Motion to approve the minutes by Supervisor John Stubbe, seconded by Supervisor Jordan Artus. Motion carries.

#### **Supervisor Report**

-Artus reports that Diamond Mowers has quoted for the 50" mower with optional wind shield screen at \$16,627 plus freight fees. This purchase was voted on and APPROVED at the Annual Town Meeting in April. Motion by Artus and seconded by Stubbe to purchase the above-mentioned mower and screen from Diamond Mowers. Monies will be drawn from the Machinery fund and transferred to the checking account. Motion carries.

-Stubbe reports that annual road work with start May 27<sup>th</sup> at 7 AM on Schoolhouse Lane from Co Road L south to Co Road A (3 miles). Also 1 mile of Grass Creek Lane from Co Rd A to Lincoln Drive will be resurfaced. Patching will also be done as needed elsewhere.

-The missing road sign at the corner of Deer Creek Lane and Wilde Drive will be replaced.

-Culvert maintenance work (replacements /opening plugged culverts) continues.

#### **Fire Department/EMR Report**

Fire Department Automatic Aid Agreements for Athens and Edgar were signed by the Town Board.

#### **Chairman Report**

-Vogel has had phone conversations with residents over the past few weeks as to dust control and road material questions.

-The bridge on Hwy A, East of Hwy H, will be replaced this coming summer. Vogel and Stubbe will be attending a preconstruction meeting at the Marathon County Hwy Dept shop on May 22.

-Future Dust control order opportunities will be included with the tax billing starting in 2026.
